RETAIL CHARGE AGREEMENT

The Consumer Credit Code, passed by the Texas Legislature in 1976, affects most retail credit sales. This law requires that:

1. The service or finance charges on accounts may not exceed 1 ½% of the unpaid balance through one billing cycle.

2. A monthly statement will be supplied to each customer showing the unpaid balance at the beginning and at the end of the billing period, and the service charge assessed for the period. Buyer and Seller hereby agree that all Goods and Services purchased by the Buyer from Seller shall be subject to the terms and provisions of this combined Buyers Statement and Retail Charge Agreement, to wit:

A. All goods and services should be paid in full 10 days from the billing shown on the Statement of purchases made by Buyer from time to time. If said Goods and Services are not paid for within 10 days from billing date, Buyer shall pay on the unpaid balance thereof a Time Price Differential not to exceed the Time Price Differential authorized by Article 6.03 of the consumer Credit Code of \$.15 per \$10 per month on the balance which is unpaid. The unpaid balance on all purchases shall be payable in full within thirty (30) days from purchase.

B. If Buyer fails to pay the balance under this Agreement when due, Seller shall have the right at Sellers option to collect a delinquent charge, accelerate maturity of balance due under this Agreement, repossess and sell Goods and Services in accordance with applicable provisions of the consumer Credit Code of Texas, and buyer shall pay all attorney's fees, court costs and disbursements
